**Minutes approved.** Shawn Tergeson moved to approve the November and December meeting minutes and Hank Reimann and Chuck Milani seconded the motion to approve the November and December meeting minutes. The motion passed unanimously.

**Ginny Ramos.** Legislative Assistant to Paul Dillon was introduced and gave a brief Council update.

- The State legislature is in session, and the Council is working on it passing a bill, 5703, that would give the Waste to Energy Plant an exemption from the Climate Control Act. Without this exemption, the city will face a fine of \$8 million or have to close the plant and landfill our solid waste. Landfills are exempted.
- The City is engaged in a pilot program with 311 for traffic calming. They are also taking requests for funding for projects, including previous ones that were not funded.

**Officer Mica Prim** gave the South Precinct update.

- Call 509 625-4150, Traffic hotline, to report traffic concerns. He reported that there has been an increase in activity of enforcement officers in the area.
- Call 3 1 1 to report illegal camping. A dedicated city outreach team can be dispatched to address the issue and connect the “campers” to community resources. The emphasis is on public safety while helping those in need.

**Tirrell Black** from City Planning was introduced and gave a presentation on Plan Spokane.

- The Comprehensive plan, as required by state law under the Growth Management Plan, is undergoing its 20-year update and must be completed by December 31, 2026. **Brendan Finch** from the Edible Tree Project, [Spokane Edible Tree Project](#), gave a presentation on his organization’s efforts to glean unwanted fruit from trees in neighborhoods throughout Spokane. He also offers training and free help with maintaining fruit trees to maximize production.

**Alex Gibilescu**, City Council Manager of Equity and Inclusion introduced himself. He is the staff member of the [Equity Subcommittee - City of Spokane, Washington](#). He talked about the importance of belonging. He talked about equity in data processing, normalizing, and operationalizing, and equitable budgeting. He said it is important to have community days celebrating our city’s many cultures and having community partnerships.

**Thomas Herrlinger** from the South Hill Library was introduced and gave an update on library activities. [South Hill - Spokane Public Library](#). He said the library now has four car

chargers, a lantern exhibit through 2/13/26, limited-edition library cards and merchandise with art from the Hive's artist-in-residence program, a Scottish Country Dance on 1/31/26 at 2:30 to 3:30 pm, and Tech Talk (free help with computers, phones and more) on 2/3/26 from 3-5 pm.
